Job Summary

The Compliance Analyst plays a critical role to ensure that Stokes Healthcare maintains the highest levels of compliance across the business through compliance with all federal, state, regulatory, and accrediting agencies. This role will support various strategic quality improvement initiatives, ensure compliance with all operating procedures and regulations, and perform internal audits. Under the direction of the Compliance Officer, the associate works to identify and address areas of vulnerability related to quality and regulatory compliance. This includes reviewing and analyzing policies, regulations and compliance requirements that could impact pharmacy licensure and accreditation.

Essential Duties and Responsibilities include the following. Other duties may be assigned.

- Ensure compliance with all state and federal regulations as well as those pertaining to USP, ACHC and NABP
- Read, interpret, summarize, Federal and State regulations and policies
- Perform audits on operations and quality system to determine the level of compliance to existing and newly instituted regulatory procedures and or corrective action plans
- Communicate with individual departments to notify and address non-compliance issues
- Assist in communication, coordination and management of external and mock audit
- Prepare documentation for submission to state and federal agencies
- Investigate potential issues of regulatory and or privacy (HIPAA) non-compliance and assist with root cause analysis, corrective action and impact reports for internal departments
- Document and maintain project plans and status reports as related to compliance programs, mock inspections, audits, and other ad hoc initiatives as needed

- Minimum 1 year of professional work experience in quality and/or compliance experience in a compounding pharmacy setting preferred
